Promotional information:

1. Students who chooses to extend their stay for Semester 1, 2021, can avail the price freeze with the similar conditions existing in current contract. If they wish to change any condition from their current contract, they need to get in touch with the property or sales team by emailing hello@atira.com or visiting reception.
2. At the time of booking confirmation, eligible residents will receive a \$50 gift card to spend as they wish.
3. Students who re-new and finalise their contract with Atira will also receive a gift voucher valued at \$500 AUD for 12-month bookings and \$200 AUD for 6-month bookings, twelve weeks after their contract start date in 2021.
